Current Situation:

The ad-hoc workgroup met on October 13th to discuss the issues raised at the September Coordinating Committee meeting. The group reviewed the research provided by H-GAC staff on other Coordinating Committees. The group decided that a formal size cap and time limit is not necessary and can be addressed if it becomes an issue.

The workgroup reviewed the process again for joinability. Specific organizations and individuals will be sent the application materials by workgroup members based on the gap assessment in addition to the materials being posted on the website (open for any organization to apply).

Applicants will complete the interest form and will also receive the background information explaining the role of the Coordinating Committee. The interest form will be an interactive form. Completed interest forms will be reviewed by an evaluation committee who will subsequently provide a recommendation to the Coordinating Committee. Per the Bylaws, an affirmative vote of three-fifths of the Coordinating Committee members is necessary to add additional members to the Coordinating Committee.

The goal is to have new members on board by the January 2012 meeting. Proposed timeline to meet this goal:

- Application materials released and posted on sustainability website by November 4th
- Applications due by December 5th to allow time for evaluation committee to review
- New members voted on at December 19th Coordinating Committee meeting

Background:

JOINABILITY

At the September Coordinating Committee meeting the proposed action on approving the process and timeline for joinability was tabled and a request made for the ad-hoc group on joinability to meet and discuss if a size and/or time limit is needed for adding additional members to the Coordinating Committee. A request was also made to research how other grantees have structured their Coordinating Committees.

Current Situation:

The ad-hoc workgroup met on October 13th to discuss the issues raised at the September Coordinating Committee meeting. The workgroup reviewed the research provided by H-GAC staff on other Coordinating Committees. The group decided that a formal size cap and time limit is not necessary and can be addressed if it becomes an issue. After substantial discussion on the pros and cons of limiting the size of the group, timing of adding members, balance between governmental and non-governmental agencies, and gaps in the Coordinating Committee; the workgroup decided that if a future need is identified to address a critical gap within the Coordinating Committee, the Committee may vote to open a Joinablity process in the future after a semi-annual needs assessment review of membership.

The workgroup reviewed the process again for joinability. They discussed the gaps and potential organization that could potentially fulfill these gaps. Specific organizations and individuals will be sent the application materials by workgroup members based on the gap assessment in addition to the materials being posted on the website (open for any organization to apply). It was also discussed that the Coordinating Committee may contact potential members to submit an application during the submittal period (open to any interested organization) to address the gaps identified.

Applicants will complete the interest form and will also receive the background information explaining the role of the Coordinating Committee. The interest form will be an interactive form. Completed interest forms will be reviewed by an evaluation committee who will subsequently provide a recommendation with justification to the Coordinating Committee. Per the Bylaws, an affirmative vote of three-fifths of the Coordinating Committee members is necessary to add additional members to the Coordinating Committee. Once the joinability review process is completed, if it is determined that new members shall be added, the goal is to have new members on board by the January 2012 meeting.

Process:

- Post application material and submittal deadline online for potential applicants.
- Joinablity subcommittee will evaluate the application to develop recommendation with justification
- Coordinating Committee will vote on subcommittee recommendation

Timeline

- Application materials released and posted on sustainability website by November 4th
- Applications due by December 5th to allow time for evaluation committee to review
- Potential new members voted on at December 19th Coordinating Committee meeting
